Cash Donations

NASTY COURT CASE IN FAVOR OF IRS!!!

Protect yourself by obtaining a written acknowledgement from the charity that is dated before April 15, 2014 that specifically states:

"YOU DID NOT RECEIVE ANY GOODS OR SERVICES IN RETURN FOR YOU DONATION"

Federal Tax Rates

- 0% rate on capital gains and dividends still exists!
- BUT, the "wealthy" capital gains and dividends goes up from 15% to 20%
- NEW ordinary income tax rate of 39.6%
- <u>Two additional taxes begin in 2013</u>....there is a 3.8% Surtax on net investment income and a 0.9% Medicare tax on earned income.

Broker Reporting of Covered Securities

Have YOU received a letter from your financial advisor asking YOU about tax basis and tax elections? If yes, what should YOU do?

Tax Deductions and Personal Exemptions UP TO 80% PHASE OUT

This was suspended two years ago but brought back in 2013 for single taxpayers with income over \$250,000 and married couple with income over \$300,000.

Education Credits



The first 4 years of college are now covered by one credit that maxes out at \$2,500 per student per year. The nice thing about this credit is that up to \$1,000 is refundable.

Mileage Rates

The 2013 business rate was 56.5 cents per mile, the medical/moving rate was 24 cents and the charity rate was 14 cents. The business rate for 2014 is 56 cents and the medical/moving rate is 23.5 cents.

Minnesota Sales & Use Tax

▲WARNING

We continue to see sales/use tax audits, and chances are they will eventually audit you! Suggestions:

- ✓ Keep the backup documents for purchases by credit card
- ✓ Monthly CC statements are not enough to show you paid the sales tax
- ✓ Up-to-date and accurate Exemption Certificates are a must

S Corporation Shareholder Wages

Do YOU <u>own</u> and are YOU <u>active</u> in an S Corporation? Then YOU <u>need to take a wage!</u>

Penalties for Late Filings of Tax Returns

- Penalty is \$195 per partner/shareholder per month with a maximum of \$2,340
- S Corporation tax returns due March 15
- Partnership tax returns due April 15
- Extensions are still allowed until September 15

New Rules for Repairs and Maintenance Expenses STARTING IN 2014

There are many facets including normal wear and tear repairs, major repairs to equipment and buildings, rotable parts and production supplies. Small businesses may need written elections. We will discuss this with you to be sure we start off properly.

Health Insurance Issues

The news this past year was full of reports that people could not successfully navigate the Federal and Minnesota website to apply for health insurance. And for employers, there was confusing



news about what they need to do and when. More regulations are coming out as this newsletter is being written.

Estate/Gift Tax

For Federal tax purposes, each person can exclude \$5.25 million and a married couple can exclude \$10.5 million of assets from estate tax when they die. Minnesota's exclusion is much lower. It has always been \$1 million and in 2013 Minnesota added a GIFT TAX once lifetime gifts exceed \$1 million. The tally starts with gifts after June 30, 2013.

Not For Profits

If you are involved with a NFP pay attention to the Form 1099 item. Even non-profits are required to file if the organization pays anyone \$600 or more during the year. This could be coaches, referees, bookkeepers, etc.

There was a court case in 2013 that went against a booster club that earmarked fundraising proceeds to the individuals who raised the funds. This specific case applied to kids who sell SCRIPT. All of the booster clubs we work with have fundraisers and may need to modify their policies.

DOMA

As you know, the Supreme Court struck down the Federal law defining marriage as a union between a man and woman. Also, Minnesota made same sex marriages legal starting August 1st. This didn't really create an income tax issue; all married couples are required to file married/joint, unless they are legally separated. Same sex partners will see their income taxes go up, just like married couples have seen forever. The real issue is with employer benefits such as dependent medical and retirement plans.

Identity Theft

Protecting your Confidentiality

form signed by you before we can send out any of your information. We have that template; it is different from the letter your banker may give you. It's another reason your personal Online Client Access account is valuable.


